##### **APFSCIL FOOTBALL LEAGUE REPORT – Mon 7th June**

After another competitive season in both divisions, Aberdeen took the Division One title with only one defeat in their 18 games and Sunderland won the Division Two title having lost none of their 20 matches. Congratulations to both sides for top quality, consistent performances across the year.

In Division One Norwich finished the season as runner's up, as did London Scottish in Division Two. Well done to them too.

Clubs from both Divisions made it to the semi-finals of the DB Cup this year, but the final was contested by arguably the two best sides in the League in Aberdeen & Norwich City at Holmesdale FC near Bromley. Aberdeen eventually ran out winners 3-0 to complete a League & Cup double, but the game was closer than the result suggests.

With the demise of the Republic Of Ireland Soccer Supporters Club in Division One, and the possibility of one or two other clubs folding, final promotion and relegation issues have yet to be resolved, and will be finally decided at the League's AGM later this month.
